B. PURPOSE OF THE POST: Why the post exists and what it has to achieve

Deploy and operate Mobile Safety Vehicles (MSVs) at sites throughout the Area.

Detect motor vehicles being driven in such a manner to contravene Road Traffic legislation in relation to Level Crossing misuse.

Set up and operate MSV CCTV and ANPR equipment, download CDs and DVDs as evidence and document in compliance with Force Policy.

Contribute towards changing driver behaviour and reducing road casualties.

Undertake related processes to identify offenders.

Produce high-quality prosecution files which would require a judicial disposal and attend Court to give evidence when required.

Use deployment experience to help identify priority locations for future MSV deployments and liaise with relevant Area Management and Network Rail to facilitate the monthly tasking process.

Shift work will be involved.

# D. PRINCIPAL ACCOUNTABILITIES: What the job is accountable for and required to deliver

## **MSV Operation:**

Maintain, prepare and operate MSV fitted with Technical, Camera and associated Survey Equipment. Carry out daily calibration of camera equipment.

Deploy MSVs to meet the requirements of the monthly tasking process.

Responsible for identifying level crossing offences.

Monitor, assess, detect and capture images for processing of motor vehicles of all classes driven in contravention of Road Traffic Legislation.

Ensure vehicle and equipment is in good working order. Identify faults affecting MSV equipment / operation and liaise with the relevant supplier(s) to ensure prompt resolution with a minimum of abstractions to MSV deployments.

Maintain effective liaison with Network Rail and other stakeholders to maximise the operational effectiveness of MSV deployments and ensure that all relevant processes are adhered to.

## **Investigative / Prosecution Duties:**

Process digital images and data downloads from MSV deployments by interpreting evidence according to established guidelines and procedures, and submit to the relevant authorities.

Carry out PNC checks and use NSPIS and Crime systems to import and update offenders and incidents.

Ensure accurate production and issue of Notices of Intended Prosecution, Conditional offer of Fixed Penalty and other associated correspondence related to MSV activity.

Ensure all such documentation is within relevant legislative guidelines.

Compile Crime Reports and witness statements for the attention of the CPS. Ensure timely and accurate submission of these and other relevant reports as required.

Give evidence in court where and when required.

## **Administrative Duties:**

Manage digital imaging, storage, issue and retrieval administration.

Complete relevant tasking documentation and correspondence. Process incoming mail and reply to all letters received either by standard letter or if required more detailed response, thus ensuring that the individual has all the necessary and accurate information to allow them to satisfy their legal requirements.

Assist members of the public both in person and by telephone, email, fax and provide suitable advice and guidance regarding legislation and procedures

Manage appropriate filing and retrieval of all relevant documentation.

Perform general administrative duties related to MSV deployments, including the coordination and delivery of tasking activity.
