Physically download CCTV images (from a variety of different CCTV systems) and produce Master Copy evidence.

Review all images seized and disseminate all relevant footage as required (e.g. to support investigations, mispers, intelligence).

Identify CCTV images which require further forensic processing (i.e. Post Production) in order to achieve "best evidence".

Ascertain any faults/issues with CCTV systems and escalate them in accordance with SOPs

### D. PRINCIPAL ACCOUNTABILITIES: What the job is accountable for and required to deliver

Coordinate collection of analogue and digital CCTV footage (through liaison with 3rd parties), prioritise workload ensuring efficient use of time.

Perform field based first line role by viewing raw CCTV footage in situ, from multiple CCTV systems (all of which they should be proficient on), to ascertain which images will support investigations.

Secure all primary evidence (ensuring evidential integrity) by downloading CCTV footage required and produce Master Copy disks as evidential exhibits.

Report any system faults encountered during the viewing and downloading of footage to the appropriate authority in line with force policy.

Review all CCTV seized and produce still images of significant importance for the Officer in the Case.

Produce multiple copies of both still and video images as requested by Defence, Crown Prosecution Service and Courts.

Apply forensic controls to all evidence produced including packaging, exhibiting and witness statements.

Identify CCTV evidence for Post Production after consultation with the Officer in the Case. Prepare and submit any original footage together with relevant documentation stipulating what further processes are required.

Update relevant Crime Reports and other force databases with details of all CCTV activity that has taken place during the course of the investigation.

Attend court to present and support CCTV evidence as an expert witness.

#### E. DECISION MAKING:

#### Make decisions

Make decisions on which footage should be collected or downloaded first dependant upon priorities and deadlines (e.g. train CCTV footage is only retained for 3 days therefore may need retrieval first).

Decide which setting a system should be configured to before the downloading of evidence takes place, to ensure video is exported in its highest quality possible.

After review has taken place, decide what images can be considered "significant action" (i.e. need to be seen by the Court in order to prove the offence) and require "Post Production".

## Significant say in decisions

When attending a site decide what footage is of evidential value to an investigation dependant on its content, image clarity and relevance, taking into account previous stated cases.
