D. PRINCIPAL ACCOUNTABILITIES: What the job is accountable for and required to deliver

Perform office/field based first line role by viewing raw CCTV footage in situ, from multiple CCTV systems to ascertain which images will support investigations using analogue, digital or internet based systems.

Secure all primary evidence (ensuring evidential integrity) by downloading CCTV footage required and produce Master Copy evidence via physical media or internet based systems.

Report any system faults encountered during the viewing and downloading of footage to the appropriate authority.

Produce multiple copies of both still and video images (including CCTV and BWV) required for progression through the criminal justice system.

Produce basic Post Production products using a variety of different sources including CCTV, BWV and mobile phone footage.

Apply forensic controls to all evidence produced including packaging, exhibiting and witness statements.

Update relevant Crime Reports and other force databases with details of all CCTV activity that has taken place during the course of the investigation.

Act as a SME for video related issues, answering technical queries and advising of best practice from officers and other interested parties.

Attend court to present and support CCTV evidence.

Perform any other duties that are commensurate with the grade and responsibilities.

E. DECISION MAKING:

Make decisions

Make decisions on which footage should be collected or downloaded first dependant upon priorities and deadlines.

Decide which setting a system should be configured to before the downloading of evidence takes place, to ensure video is exported in its highest quality possible.

After review has taken place, decide what images can be considered "significant action" (i.e. need to be seen by the Court in order to prove the offence) and require "Post Production".

Decide on the priority of the workload to meet deadlines dependent on relevant factors connected with an investigation or the timely retention of CCTV data on Network Rail, TOC and other systems.

Significant say in decisions

When attending a site decide what footage is of evidential value to an investigation dependant on its content, image clarity and relevance, taking into account previous stated cases.

Advise Police Officers and staff of best practice regarding CCTV collection and post production processes.
