To gather, collate and disseminate real time intelligence gathered from the pro-active use of live CCTV systems ensuring that the best video evidence and still images are gathered and produced at all times, including determining the evidential value of the product prior to dissemination. Pro-actively consult with Intelligence staffs, force control supervisors, other police departments, outside agencies, train operating companies and external agencies to identify trends in crime that will inform the pro-active monitoring process. Respond to taskings and support live police operations and events taking place at railway locations covered by CCTV thereby ensuring the time critical decisions are made and passed onto the relevant control room either by completing a FIS report of creating an NSPIS.

To use force databases such as Force Intelligence System, NSPIS command and Control, Force briefing System and the Crime database in order to maintain an up to date picture of current intelligence and incidents as well as logging the production, storage and movement of any CCTV data collected

Produce evidential CCTV packages in line with the force policies and procedures.

Undertake sensitive taskings, including review of fatalities, including initial assessment of the images, in order that fast time decisions are made and the correct information quickly disseminated.

To undertake any additional duties commensurate with the grading and responsibilities of the post under the direction of line management
